

# **The Public Spaces Protection Order (Pinner Memorial Park) (Harrow Council) 2020**

Harrow Council ("The Authority") has made the following Public Spaces Protection Order under Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act")

The Order comes into force on **TO BE CONFIRMED** for a period of 3 years.

In this Order an "Authorised Officer of the Authority" means any employee of the authority who is authorised in writing by the Authority for the purpose of giving directions under this Order. "The Restricted Area" relates to all public spaces within the area as shown in schedule 1.

Authorised persons include "Authorised Officer of the Authority", Police and PCSOs (Police Community Support Officer)

## **Offences**

**For Offences listed below relate to all public spaces in the administrative area of the London Borough of Harrow ("the restricted area") shown in red on the plan shown in schedule 1 of this order.**

### **Article 1 - Dogs on Leads**

- 1.1. A person in charge of a dog shall be guilty of an offence if, at any time, their dog is not on a lead in the restricted area unless:
  - a. They have reasonable excuse for failing to do so; or
  - b. The owner, occupier or other person or authority having control of the restricted area has consented (generally or specifically) to their failing to do so
- 1.2. Any person who fails to put their dog on a lead once requested by an authorised officer shall also be guilty of an offence under this order

### **Article 2 - Dogs to be kept under proper control**

- 2.1 A person in charge of a dog in the restricted area shall be guilty of an offence if their dog is not kept under proper control
- 2.2 In this Article "proper control" means a dog being on a lead or muzzled if the dog requires it, or otherwise being at heel / close enough to the person in charge that it can be restrained if necessary or responding immediately to voice commands

### **Article 3 – Lighting of fires or using barbeques**

- 3.1 No person shall light a fire or use a barbeque, of any kind, within the restricted areas unless having the express written permission of the Authority or any person thus delegated by the Authority

### **Article 4 – Endangerment to Wildlife**

- 4.1 Any person who causes, or knowingly allows by any person or animal under their control, endangerment to wildlife shall be guilty of an offence

## **Article 5 – Feeding of Wildlife**

5.1 No person at any time shall provide or deposit food for consumption by pigeons within the designated park area

### **Penalties**

Failure to comply with any article of this Public Spaces Protection Order is a criminal offence subject to a level 3 fine on prosecution (up to £1000). Any person who fails to comply once requested to do so by an Authorised Officer shall be issued with a Fixed Penalty Notice (£100). Any further non-compliance will result in prosecution.

### **Exemptions**

Nothing in Articles 1 and 2 of this Order applies to:

- a. A disabled person (within the meaning of the Equality Act 2010) whose disability restricts their ability to comply with the article and where the dog is their guide dog or assistance dog; or
- b. A person who is training an assistance dog in an official capacity; or
- c. A dog used by the Police or other agencies permitted by the Council for official purposes

Harrow Council ("The Authority") has made the following Public Spaces Protection Order under Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act")

The Order comes into force on **TO BE CONFIRMED** for a period of 3 years.

In this Order an "Authorised Officer of the Authority" means any employee of the authority who is authorised in writing by the Authority for the purpose of giving directions under this Order. "The Restricted Area" relates to all public spaces within the area as shown in schedule 1.

Authorised persons include "Authorised Officer of the Authority", Police and PCSOs (Police Community Support Officer)

## **Offences**

**For Offences listed below relate to all public spaces in the administrative area of the London Borough of Harrow ("the restricted area") shown in red on the plan shown in schedule 1 of this order.**

### **Article 1 - Dogs on Leads**

- 1.3. A person in charge of a dog shall be guilty of an offence if, at any time, their dog is not on a lead in the restricted area unless:
  - c. They have reasonable excuse for failing to do so; or
  - d. The owner, occupier or other person or authority having control of the restricted area has consented (generally or specifically) to their failing to do so
- 1.4. Any person who fails to put their dog on a lead once requested by an authorised officer shall also be guilty of an offence under this order

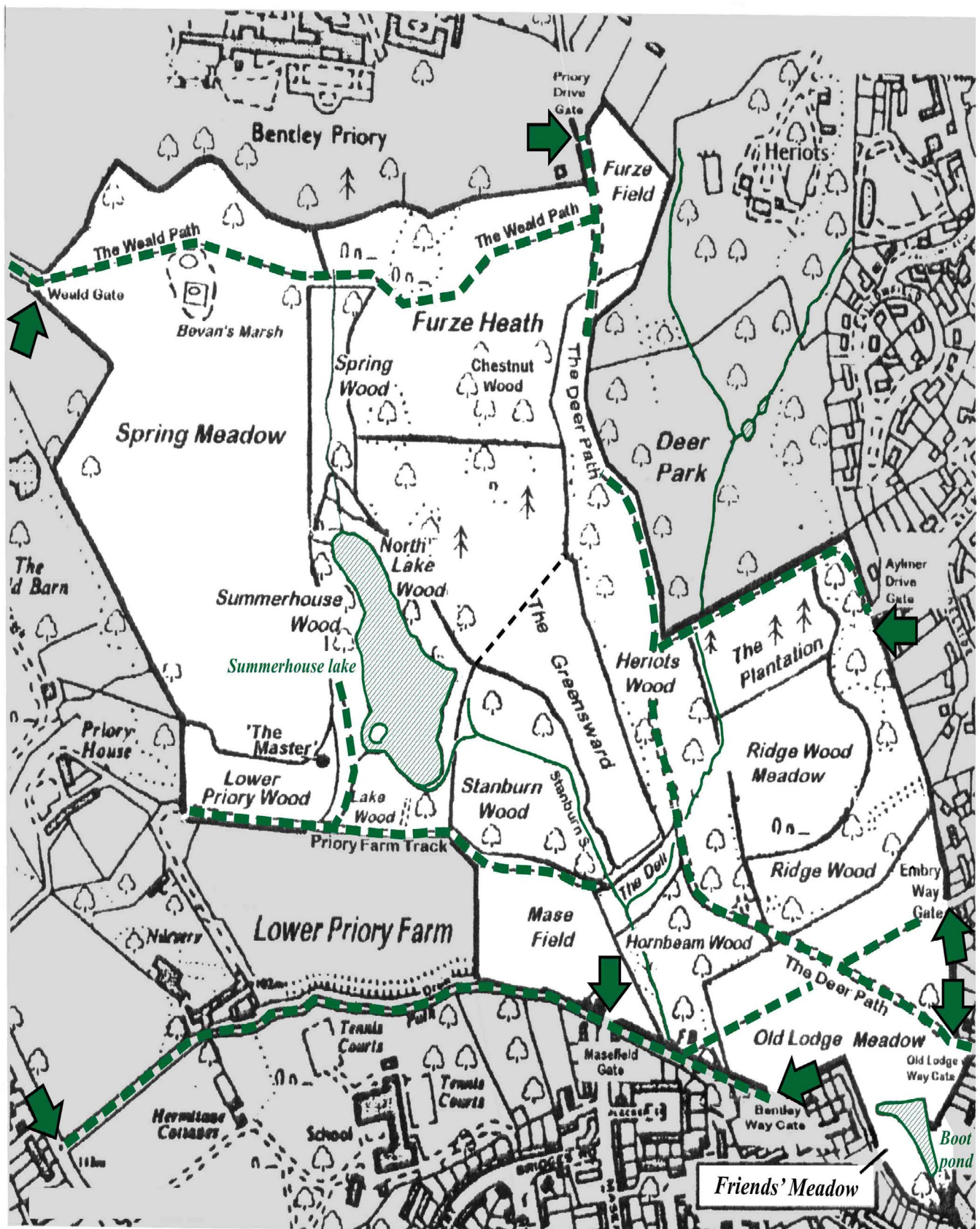

Authorised persons include "Authorised Officer of the Authority", Police and PCSOs (Police Community Support Officer)

### **Article 1 - Dogs on Leads**

  - f. The owner, occupier or other person or authority having control of the restricted area has consented (generally or specifically) to their failing to do so

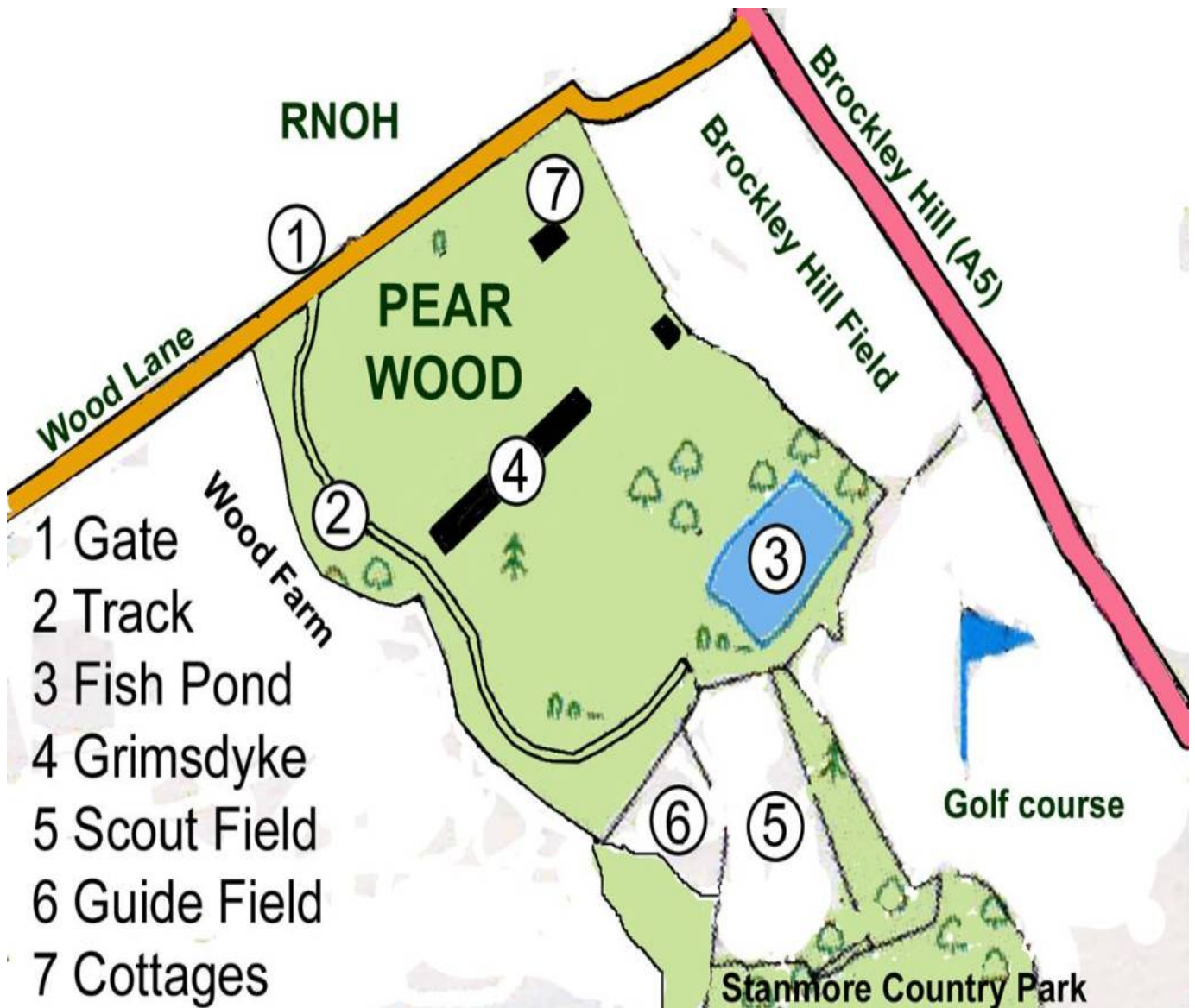
